# **Heather Ling Medeiros – PRIVACY POLICY**

This page informs you of our policies regarding the collection, use and disclosure of Personal Information we receive from users of the Site. Our lawful ground for this processing is our legitimate interests which in this case are to study how customers use our products/services, to develop them, to grow our business and to decide our marketing strategy.
- We may use Customer Data, User Data, Technical Data and Marketing Data to deliver relevant website content and advertisements to you (including Facebook adverts or other display advertisements) and to measure or understand the effectiveness of the advertising we serve you. We do not collect any Sensitive Data about you.
